As it is required by WTO Agreement on Technical Barriers to Trade (Appendix 3 of the Code of Good Practice for the Preparation, Adoption and Application of Standards) every standardization body has to publish its work programme at least once every six months.

The RSB work programme contains a list of all the draft standards that are in progress and it is published twice a year and it also gives information related to:

- Technical committee name and number
- Title of the draft standard
- The International Classification for Standards (ICS) under which each draft standard is classified
- Status of the Standard (New, Revision and Harmonization)
- Base standards considered in work to develop the draft standard, where relevant
- Stages in the development of a draft standard and the expected date of completion

How to use this publication?

1. Technical committee name and number

The second column in the left hand, indicates the technical committee name and its number under which the draft was developed

2. Title of the draft standard

The third column gives the title of each draft standard

3. International Classification for standards (ICS)

Column 4 indicates the subject under which the draft fall. The ICS numbers is a classification system developed by the International Organization for Standardization, serving primarily as a uniform structure for standards catalogues and work programmes published by standardizing bodies.

4. Reference standards

Column 5 gives reference number of standards used in developing the draft standards

5. Stages and time in standards development

Column 6 indicates the stages involved in standards development process and the time expected to publish the standard.

- **Stage 00:** Preliminary (request for a new standard approved)
- **Stage 10:** Proposal (Approved New Work Item)
- **Stage 20:** Preparatory (ANWI recorded on six month work programme and working draft developed)
- **Stage 30:** Committee Draft and technical committee meeting
- **Stage 40:** Public review of the draft standard
- **Stage 50:** Approval of Rwanda Standards
- **Stage 60:** Publication of Rwanda Standards
- **Stage 90:** Review of Rwanda Standards
