For the purpose of aligning the numbering system of Rwandan Standards with the East African Community and International standards numbering Systems;

Ingingo ya 3: Amabwiriza y'Ubuziranenge Ntarengwa

ISSUES THE FOLLOWING INSTRUCTIONS:

Article One: Purpose of the instructions

These instructions declare and enforce Rwandan Compulsory Standards.

Article 2: Definitions of terms

For the purpose of this Law, the following terms mean:

1. **Competent Authority** means Authority mandated to enforce or regulate compulsory standards.
2. **Recognized Body** includes National Certification Body; National Testing Body; National Designated Testing Laboratory; Accredited Private Certification Body or Accredited Private Testing Laboratory.

Article 3: Compulsory Standards

All Rwanda Standards appearing in the list herewith attached are hereby declared compulsory.

Article premier : Objet des instructions

Article 2 : Définition des termes

1. **Autorité Compétente** signifie Autorité ayant la mise en application des normes rwandaises obligatoires dans ses attributions.
2. Institution reconnue signifie Institution, Agence, Organisme, Division ou Direction publique ou privée reconnue d'analyse ou de certification.

Article 3 : Normes obligatoires

Toutes les normes rwandaises apparaissant dans la liste ci-jointe sont déclarées obligatoires.

Ingingo ya 4: Kubahiriza Amabwiriza y'Ubuziranenge Ntarengwa

Umuntu ku giti cye, abantu bishyize hamwe cyangwa ishyirahamwe ry'ubucuruzi ntibemerewe gukora, kwinjiza mu Gihugu, kohereza hanze y'Igihugu cyangwa gucuruza igicuruzwa kirebwa n'aya Mabwiriza y'Ubuziranenge Ntarengwa cyeretse bamaze kwerekana icyemezo gitangwa n'Urwego rubifitiye ububasha kigaragaza ko igicuruzwa cyujuje iby'ingenzi bisabwa n'Amabwiriza y'Ubuziranenge Ntarengwa.

Icyemezo kigaragaza ko igicuruzwa cyujuje iby'ingenzi bisabwa gishobora kuba:

1. Ikirango cy'Ubuziranenge gitangwa n'Urwego rwemewe rutanga Ibirango by'Ubuziranenge;
2. icyemezo kigaragaza ko ibintu byasuzumwe gitangwa n'Urwego rwemewe rushinzwe gupima;
3. Inyandiko itangwa n'Urwego rwemewe rushinzwe gupima igaragaza ko ibintu byapimwe;

Ingingo 5: Kwiyandikisha

Umuntu ku giti cye, abantu bishyize hamwe cyangwa ishyirahamwe ry'ubucuruzi binjiza mu Gihugu cyangwa bakora igicuruzwa kirebwa n'Amabwiriza y'Ubuziranenge Ntarengwa bagomba kwiyandikisha mu Rwego rushinzwe igenzura rubifitiye ububasha.

Article 4: Compliance with Compulsory Standard

A natural person, corporate body or business enterprise shall not manufacture, import, export or sell the commodity and product covered by compulsory standards regulated by these instructions without providing a proof of compliance to essential requirements of the standard to the competent authority.

A proof of compliance shall be:

1. A certification mark issued by a Recognized Certification body;
2. A certificate of analysis issued by a Recognized Testing Body; or
3. A test report issued by a Recognized Testing Body.

Article 5: Registration

Any natural person, corporate body or business enterprise importing or manufacturing products falling under the scope of Compulsory Standards shall register with the relevant Competent Authority.

Article 4 : Conformité à la norme obligatoire

Une personne physique, morale ou entreprise commerciale ne doit pas fabriquer, importer, exporter ou vendre un produit couvert par les normes obligatoires dont la liste est attachée aux présentes instructions, sans fournir ou montrer à l'autorité compétente d'une preuve de conformité aux exigences essentielles de la norme.

La preuve de conformité peut être :

1. Une marque de certification délivrée par une institution de certification reconnue ;
2. Un certificat d'analyse délivrée par une institution d'analyse reconnue ;
3. Un rapport d'analyse délivrée par une institution d'analyse reconnue.

Article 5: Inscription

Toute personne physique, morale ou entreprise commerciale qui importe ou fabrique un produit relevant du champ d'application des normes obligatoires doit s'inscrire auprès de l'autorité compétente de régulation.

Ingingo 6: icyaha

Umuntu ku giti cye, abantu bishyize hamwe cyangwa ishyirahamwe ry'ubucuruzi batubahirije ibiteganywa n'Amabwiriza y'Ubuziranenge Ntarengwa baba bakoze icyaha kandi bahanwa hakurikijwe amategeko agenga ubucuruzi mu Rwanda.

Ingingo 7: Ishyirwa mu bikorwa

Inzego zose za Leta bireba zisabwe gufatanywa no kugira imikoranye myiza hagati yazo hagamijwe ishyirwa mu bikorwa n'iyubahirizwa ry'aya mabwiriza ya Minisitiri ashiraho Amabwiriza Nyarwanda y'Ubuziranenge Ntarengwa.

Ingingo 8: Gusubiramo Amabwiriza

Aya mabwiriza ya Minisitiri kimwe n'Amabwiriza Nyarwanda y'Ubuziranenge Ntarengwa ari ku mugereka wayo bishobora gusubirwamo no guhindurwa igihe cyose bibaye ngombwa kandi bikwiye.

Ingingo ya 9: Ivanwaho ry'Amabwiriza y'Ubuziranenge Ntarengwa

Amabwiriza n° 02/2005 yo kuwa 19/05/2005 y'Ikigo cy'Igihugu Gitsura Ubuziranenge ashiraho Amabwiriza Nyarwanda y'Ubuziranenge Ntarengwa avanyweho.

Article 6: Offense

Any natural person, corporate body or business enterprise not complying with compulsory standards commits an offense and is punishable by relevant laws and regulations applicable in Rwanda.

Article 7: Enforcement

All concerned government institutions are requested to collaborate to ensure effective enforcement of these Ministerial instructions and the listed compulsory standards.

Article 8: Review

These instructions and attached list of compulsory standards shall be reviewed from time to time as deemed necessary and appropriate.

Article 9: Repealing provision

Instructions n°02/2005 of 19/05/2005 of Rwanda Bureau of Standards declaring compulsory Rwanda Standards are hereby repealed.

Article 6: Infraction

Toute personne physique ou corps et de l'Entreprise des sociétés ne répondant pas aux normes obligatoires commet une infraction et est punissable selon les lois et règlements en la matière qui sont en vigueur au Rwanda.

Article 7 : Exécution

Toutes les institutions gouvernementales concernées sont invitées à collaborer pour assurer l'exécution effective de ces instructions ministérielles et les normes obligatoires dont la liste est attachée.

Article 8: Révision

Les présentes instructions et la liste ci-jointe des normes obligatoires pourront être révisées de temps en temps selon la nécessité.

Article 9 : Disposition abrogatoire

Les Instructions n°02/2005 du 19/05/2005 de l'Office Rwandais de Normalisation déclarant les normes rwandaises obligatoires sont abrogées.

Ingingo ya mbere: icyo aya mabwiriza agamije

Aya mabwiriza agamije gushyiraho uburyo bwo korohereza abatuye cyangwa abagenda mu Mujyi wa Kigali hashyirwaho ibyapa bifite numero bishyirwa ku nyubako iri ku muhanda mu Mujyi wa Kigali.

Mu ikubitiro, aya mabwiriza areba inyubako y'umuntu ku giti cye, iy'ikigo cy'abikorera, iya leta cyangwa indi nyubako iyo ariyo yose iri ku muhanda mu Mujyi wa Kigali nk'uko bigaragara ku mugereka no 1 w'aya mabwiriza.

Ingingo ya 2 : Numero ku cyapa

Buri nyubako iri ku muhanda mu Mujyi wa Kigali igomba kugira icyapa gifite numero iyiranga itangwa hashingiwe ku buryo inyubako zikurikirana kuri uwo muhanda.

Icyakora, inyubako ziri ku muhanda mu kuboko kw'ibumoso kwawo zihabwa umubare w'igiharwe naho iziri mu kuboko kw'iburyo zigahabwa numero igabanyika kabiri uherye aho umuhanda utangirira.

Umubare wandikwa ku cyapa utangwa n'urwego rubifitiye ububasha.

Article One: Purpose of these instructions

These instructions establish the way of facilitating citizens and visitors of the City of Kigali by putting house number plates on houses/building along streets and roads in the City of Kigali for directive purpose.

Primarily these instructions concern all houses/buildings either owned by an individual, public or private agency, organization, government institutions located along the streets in the City of Kigali as shown by the annex no 1 attached to these instructions

Article 2: The number on the house number plate

Every house/building located on the street of City of Kigali shall be identified by a number on house number plate which shall be allocated according to the order of the buildings on that street.

However, houses/buildings located on the left side of the street shall bear an "Odd-numbers", and for the houses/buildings located on the right side of the street shall bear an "Even-numbers" starting from the beginning of the street.

The number on the house number plate shall be attributed by the competent authority

Article premier: Objet des instructions

Les présentes instructions déterminent la façon de faciliter les citoyens et les visiteurs de la Ville de Kigali en mettant les plaques d'immatriculation des maisons sur des maisons au long de rues et avenues de la ville de Kigali.

Premièrement ces instructions concernent des immeubles appartenant à un particulier, des entreprises privées ou publiques, des institutions publiques situés le long des rues de la Ville de Kigali comme indiqué en annexe no 1 de présentes instructions.

Article 2: Numéro indicatif sur la plaque d'immatriculation de maison

Chaque bâtiment situé sur la rue, avenue et route de la Ville de Kigali est identifié par un numéro sur la plaque d'immatriculation de maison qui doit être attribué selon l'ordre des bâtiments de cette rue.

Toutefois, les bâtiments situés sur le côté gauche de la rue doivent porter des nombres impairs, et pour les bâtiments situés sur le côté droit de la rue de nombres pairs à partir du début de la rue.

Le numéro mentionné sur la plaque d'immatriculation de maison est délivré par l'autorité compétente.

Ingingo ya 3: Imiterere y'icyapa

Icyapa cyandikwaho numero iranga inyubako kigomba kuba:

1. gifite santimetero mirongo ine (40 cm) z'uburebure na santimetero makumyabiri n'eshanu z'ubugari (25cm);
2. gikozwe mu cyuma (material) cya "enamelled steel" cyangwa "chromadek";
3. gifite ibara rimwe rituma ibyanditseho bigaragara neza;
4. cyanditseho numero yihariye iranga inyubako.

Umuzenguruko w'icyapa, inyuguti n'umubare bigomba kuba bigaragara ku manywa na nijoro mu gihe hamuritsweho urumuri. Umubare wanditse ku cyapa ugomba kuba ugagarara neza. (Umugereka no 2)

Ingingo ya 4: Ahashyirwa icyapa

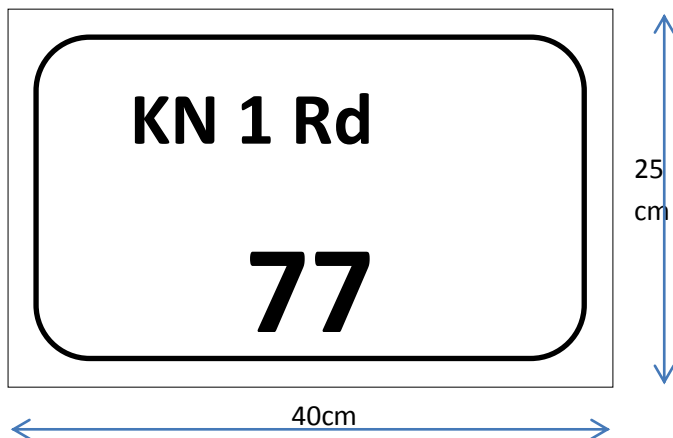

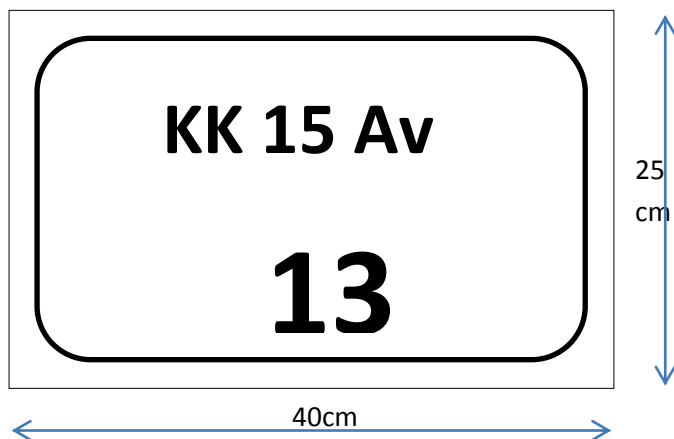

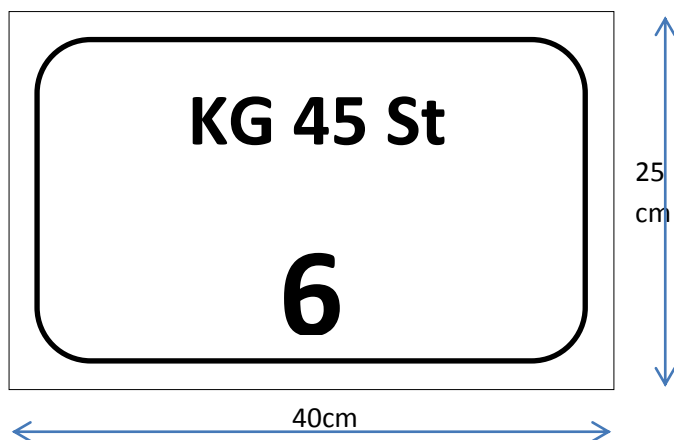
